AN ACT TO AMEND THE PROCEEDS OF CRIME ACT, CHAP 12: 29

(Gazetted 20th May, 2010)

BE IT ENACTED by the Parliament of the Commonwealth of Dominica as follows:

1. This Act may be cited as the –

# PROCEEDS OF CRIME (AMENDMENT)

**ACT 10** 

Interpretation

**2.** In this Act the Proceeds of Crime Act Chap 12:29 is referred to as "the Act."

Amendment of section 2

- 3. Section 2 of the Act is amended by
  - (a) inserting a definition of "financial institution" between the terms 'the court' and forfeiture order' as follows:

"financial institution" means any person whose regular occupation or business is the carrying on of any activity listed in the Schedule II;"

(b) deleting the word "the" appearing immediately before the word "Schedule" in the definition of the term "scheduled offences" and inserting the figure "I" immediately after the word "Schedule."

Deletion of Scheduleand insertion of new Schedule

**4.** The Schedule, "List of Offences" is hereby repealed and replaced as "Schedule I" list of offences and a new schedule, Schedule II is inserted as follows:
